

## Zurich Self Invested Pension Plan

# Authorisation of one-off adviser charge

If you have agreed with your adviser to pay them for their services from your Zurich Self Invested Pension Plan (SIPP), you will need to complete this form. If you have more than one Zurich Self Invested Pension Plan, you should complete a separate form for each plan.

A one-off adviser charge can only be paid for regulated financial advice from your Zurich Self Invested Pension Plan when requesting full or partial drawdown.

### An adviser charge cannot be paid:

- as an ongoing adviser charge from your Zurich SIPP
- if your plan is already in drawdown and an adviser charge has not previously been paid
- if your adviser is already taking an ongoing charge in the form of trail fees
- when adding additional funds to your plan, regardless of whether an adviser charge is already being paid.

When taking further drawdown, you will need to complete a new form if you wish to pay an adviser charge.

### Where partial drawdown is requested:

If you would like to pay the adviser charge by crystallising your benefits from wider SIPP assets, please complete section 3. Crystallising is the process of accessing or drawing down your pension fund to provide you with a retirement income. We will sell units to cover the adviser charge on the same basis as you've chosen for your tax free lump sum.

Your adviser can help you to complete this form.

The way we ask for your authority to pay the one-off adviser charge may change in the future.

Please use blue or black ink and BLOCK CAPITALS. Please check that this form is completed correctly, signed and returned to us.

#### Notes

- Payments can only be made to the adviser shown in our records as acting for the SIPP.
- The one-off adviser charge will only be paid upon production of an invoice from the adviser. Please submit with the application form.
